Alcohol Focus Scotland is the national charity working to prevent and reduce alcohol-related harm.

We want to reduce the impact of alcohol on individuals, families, communities, and Scotland as a whole, through calling on Government for effective alcohol control policies and legislation. We want to see fewer people have their health damaged or lives cut short due to alcohol, fewer children and families suffering as a result of other people's drinking, and communities free from alcohol-related crime and violence.

Since 1985, we have been:

- gathering evidence of the harm caused by alcohol and of the most effective and cost-effective policies
- promoting effective alcohol policies at local, national, and international level
- engaging and informing people about our work and the need for change
- · developing learning opportunities and resources to support best practice

Our funding comes from the Scottish Government, grant giving bodies, and self-generated income from our training programmes. We do not accept funding from the alcohol industry.

Involvement

We work with children and young people and people in recovery from an alcohol problem to help develop and share their views with decision makers. Involvement helps us understand how alcohol affects the lives of people in Scotland.

Policy & Research

We research and share evidence of the harm that alcohol can cause, and how it can be reduced to save and improve lives.

Learning & Development

We offer a variety of opportunities to help people understand, manage, and prevent the harm caused by alcohol, including for children affected by someone else's alcohol use.

Involvement

We deliver **workshops to schools and youth clubs** on different topics around alcohol, exploring the impact it has on all of us and our communities.

We wanted to **show decision makers** how alcohol marketing impacts people in recovery and children and young people. We listened to people's views and experiences, then brought them to life through animations. The people we worked with provided the voiceovers for the animations.

Young people came with us when we **presented the animations in Parliament**, and got to meet their local MSP!

These animations have helped us **share the views** of the people we work with widely – including at the Global Alcohol Policy Conference in South Africa!

Policy & Research

Learning & Development

Alcohol Focus Scotland provides **resources and training** for early years workers, teachers, and others working with children and young people affected by a family member's drinking, including:

- Oh Lila! for children aged 3-6 years
- Rory for children from P1 to P7
- The Children Harmed by Alcohol Toolkit for children and young people aged 3 to 18 years

With £3,000 we can train and provide the resources to at least **30 workers and teachers** who can go on to help hundreds, if not thousands of children, in their day to day work!
