Evidence considered by licensing boards to develop policy

Licensing boards have a statutory duty to ensure that the measures included in their policy statements seek to promote the licensing objectives. It is therefore incumbent on them to gather sufficient information to ensure that the policy measures they adopt serve to promote the objectives. Sources of evidence can include consultation responses, surveys of the local population, and a broad range of statistical information available at national and local levels. The below table outlines some of the information and sources cited by boards as being used to develop their most recent policy statements.

It allows targeting of policies where the aim is to wholly or partly take account of area concentrations of multiple deprivation. 	Local Authority Profiles	Thirty Local Authority Profiles, containing similar information as the Scotland profile (above) but using data at local authority level.
Alcohol and Drug Partnerships	Local Area Alcohol Profiles	Reports pulling together a broad range of data, including: number of people engaged in ADP alcohol related services, alcohol related hospital admissions, alcohol related death rate, alcohol related mental health, alcohol related brain damage, police incidents (including assaults, domestic incidents, disorder and alcohol specific crimes), and relevant fire statistics. Many include statistical information for each Intermediate Data Zones (IDZ) showing alcohol-related health harms and alcohol-related crime to be above the local authority average. Some set out recommendations to licensing boards on the levels of provision, and possible overprovision, of alcohol licences based on analysis of available data including from local data sources (in some cases, for on-licences, including the maximum licensed capacity).

This brings together data on alcohol sales, alcohol price, self-reported consumption, alcohol specific deaths, alcohol related hospitalisations and social harms.
Glasgow Centre for Population Health	Mental Health in Focus	Report providing a description of mental health in GG&C, using over 51 indicators of mental health, wellbeing and related contextual factors. Inequalities in mental health are explored, specifically across area deprivation, age and sex. It includes details of mental health-related alcohol deaths
National Records of Scotland	The Registrar General's Annual Review of Demographic Trends	The Annual Review contains an overview of Scotland's population. It includes statistics on births, deaths, life expectancy, migration, marriage and civil partnership, adoption, households and housing, and statutory registration.
	Mid-Year Population Estimates	Annual mid-year population estimates for Scotland and its constituent NHS Board and council areas.
